This will be included into the SFB S&C vision and new pitch.*

4. **ProExec report on Security - SFB area** LS
- 4.1 November Reports sent to members weekly.  
*- LS advised his challenges over this time:- illegal drinking in public; littering; loitering, walking on the rocks unstable; buskers – all need to have permits. Motorised units not permissible on Promenade. Need more liaison with SAPS and Law Enforcement. Meeting to be set up with Col Engelbrecht (SAPS) and LE (date will be circulated to Exco)* **TvE**
- 4.2 **Update** on Segways, NineBot, Patroller:  
*- SFB have 4 sponsored Ninebots (Blok, STBB, Spur & Faircape). Four operating in the day time and 3 at night.*
- 4.3 **Operations** – these are ongoing in conjunction with the Fieldworker.
- 4.4 **General** – *There has been a spate of Remote jammers reported on Beach front and surrounding roads. A Security Alert will go out to the database* **TvE**
5. **Fieldworker report** Jantjie B
- *November report and Street People workshop tabled.*
  - *The number of mental patients (released by Govt from Mental Institutions) on the street is of growing concern. It is a lengthy process, SAPS have to be called and SAPS have to start the legal process. Jantjie to find out exact details of procedure. Concern: “Revolving door” situ – after one month they (mental patients) are back on the street. This has a negative impact on tourism.*
  - *Jantjie needs a space on Promenade for assessments, Cllr Ramsay is meeting with Social Development and will revert.* **SR**
- Issues:-**  
*Pay officials to do a job; need to keep the City to performance*
- *Issue bigger than Ratepayers Association*
  - *There is no direction from the City*
  - *Straddling all and Affecting allNeed a strategy to get attention and needs to be addressed*
  - *Security in the City Centre are pushing the displaced persons into other areas*
  - *Social Development (Peter Cookson & Muneeb Jacobs) are running a pilot in the City on displaced persons and have not included neighbouring SFB nor MPRA.*
  - *Complicated problem.*
  - *Law on side of homeless.*
- Action:** *David P to draft letter to the City Manager recording / summarising the Social & Security situation and what the issues are and the increased violence.  
Also a letter to Alan Winde (WC Minister of Economic Opportunities) and to Tim Harris of Wesgro* **DP**
