4.1. Update

- Improvement, things are getting better

7. **Discuss strategic imperatives for 2017**

9. Ward Committee Member Feedback Report

9.1 Update on report re: Sewage in the Ocean

Kevin Samson (Wastewater Dept) and Gregg Oelofse (Environmental Resource Management Department) attended.

- A year of testing by CSIR has now concluded.
- Sampling was conducted about six times per month at multiple locations in the following areas
 - Ocean (Green Point, Hout Bay, Camps Bay/Clifton) every three weeks;
 - Beaches (Clifton and Camps Bay and Hout Bay) every two weeks,
 - Blue Flag beaches (Clifton and Camps Bay) every two weeks.
- Because of the controversy surrounding the topic, the City are appointing an independent consultant to evaluate the methodology used and adequacy of results. The full report will be published about end June.
- The outfalls are working as designed. I asked if that indeed is good enough. If international standards are the benchmark, the answer is yes (but see Water Watch link below).
- Most of the time it is difficult to detect measurable bacteria and at Camps Bay and Clifton bacteria are virtually undetectable.
- The deep water outfall system is 30 years old, and is operating below design capacity. It will remain sustainable for a good many years to come.
- The Green Point outfall serves the area between Woodstock and Bantry Bay. This outfall can cope with the current and envisaged developments in the area.
- There was extensive input from Camps Bay Ward Committee members, especially those who work for NSRI and are exposed to outfall near Maiden's Cove.
- The meeting asked for costs to extend the pipeline in Camps Bay a further 50 metres.
- And on a lighter note, cholesterol medication count is higher in Camps Bay than in Green Point but Sea Point wins the blood pressure meds stakes.
- Apropos the question on testing costs, Water Watch SA (<https://www.backabuddy.co.za/champion/project/water-watch-sa>) needed R 7000 to test two samples three times a week, mid November to end March. That places the cost per test at around R120 each.
- I've asked Gregg to send me a copy of his presentation for circulation.

On Water Restrictions, Sarah Rushmere (CCT) gave an extensive report:

- 65% Of water usage is from the formal housing sector. Agriculture accounts for the next biggest usage. Relative to these, the informal sector usage is minimal.
- We should scrape through the current situation but, if winter doesn't deliver sufficient rain, next year will require crisis measures.
- The City is gradually reducing water pressure.
- We have the same level of current consumption as in 2004.
- I expressed concern that the City had been very slow to react to the present crisis and also asked about exemptions. These are no longer being granted.
- I've requested a copy of Sarah's report and will circulate.

- Main problem is that blocks are not paying their Annual Membership fees. Their reason are lack of funds due to the increase in Levy's to comply with new Sectional Title Act.
 - MvE suggests dropping it to R50
 - It has been decided that SFB Annual Membership will stay at R70 per year with blocks contributing to the Safety & Cleaning Initiative paying R25 annually
 - SK will issue credit notes to contributing blocks
 - LL to note for AGM 2018, Annual membership will increase to R100
